

UPJ GOVERNANCE COURSE AUGUST-SEPTEMBER 2024

OVERVIEW OF THE COURSE

The UPJ Governance Course for Synagogue Board Members and potential Board members will provide participants with an understanding of fundamental compliance and performance related roles and responsibilities of board members. The focus will be in the areas of:

- 1. Jewish values and roles of the rabbi, staff, and the board.
- 2. Governance and the role of board members, including legal responsibilities, compliance and risk management
- 3. Financial planning and performance management; strategy and operational implementation
- 4. Board recruitment and induction; maximising the effectiveness of the Board

WHO SHOULD ATTEND

The course is designed for members of synagogue boards, especially members with little experience in not-forprofit organisational management.

UPON COMPLETION OF THIS COURSE, YOU WILL BE ABLE TO UNDERSTAND:

- > The key duties and responsibilities of board members in the not-for-profit environment.
- > The interaction of Jewish values and board management functions related to rabbis and staff.
- > Processes for building an effective, purposeful Board
- > The role of Board members in overseeing strategy formulation and risk management
- > The nature of financial statements for not-for-profit organisations.

You will also have the opportunity to build a network of board member contacts across the UPJ for long-term communication and collaboration.

WHAT TO EXPECT

- > Participants should expect to attend all sessions and participate in discussions.
- > Approximately one-hour preparation before each session, mainly reading materials to facilitate group interaction and discussion.
- > Conduct a case study-based project with colleagues to utilise skills and knowledge developed during the course

The course will be taught in an interactive manner by our facilitator, David Fishel from Positive Solutions, who has extensive experience in the not-for-profit sector, and led a previous UPJ governance program in 2022. He will be supported by several highly experienced members of the UPJ community, who will contribute to discussion of governance and management of boards in a Progressive Jewish context.
